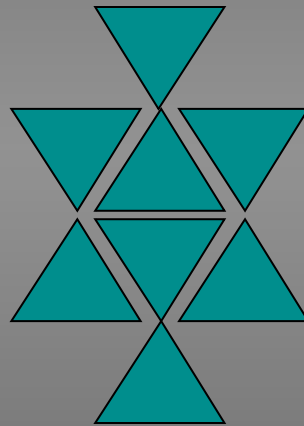

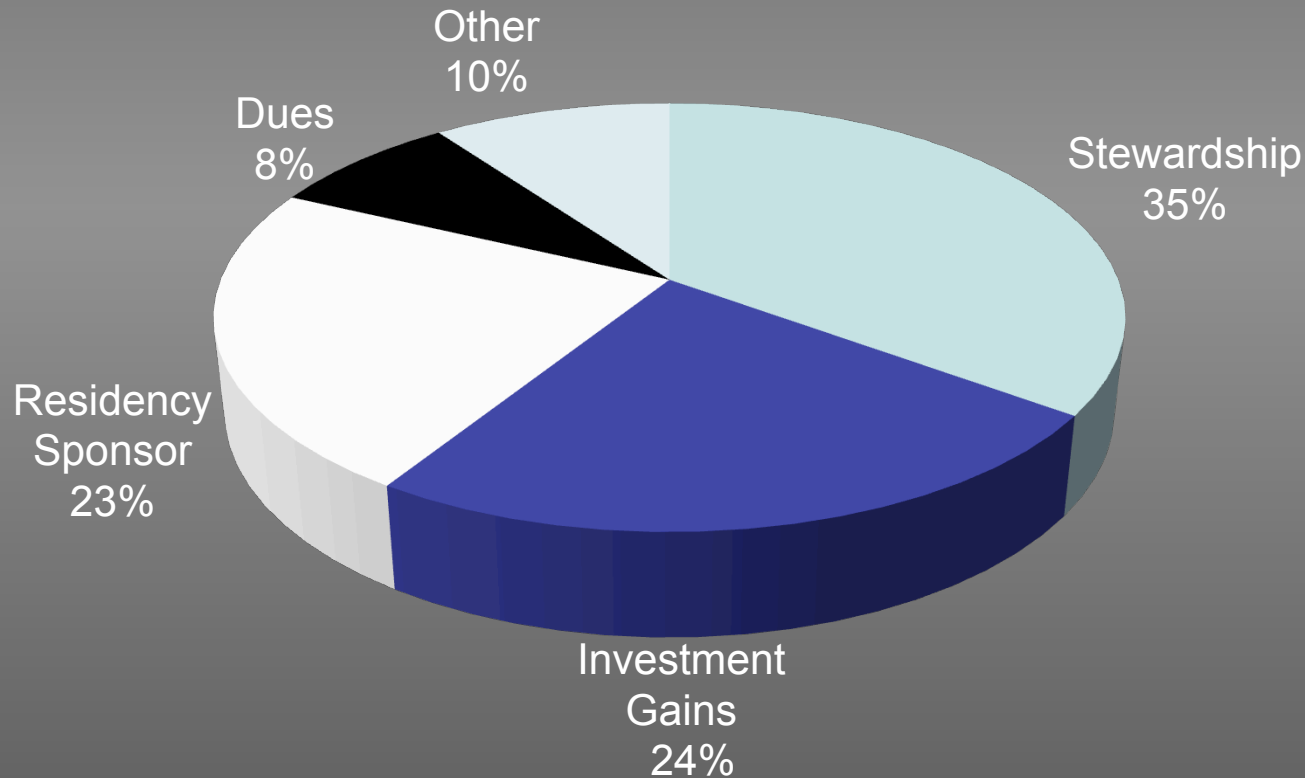

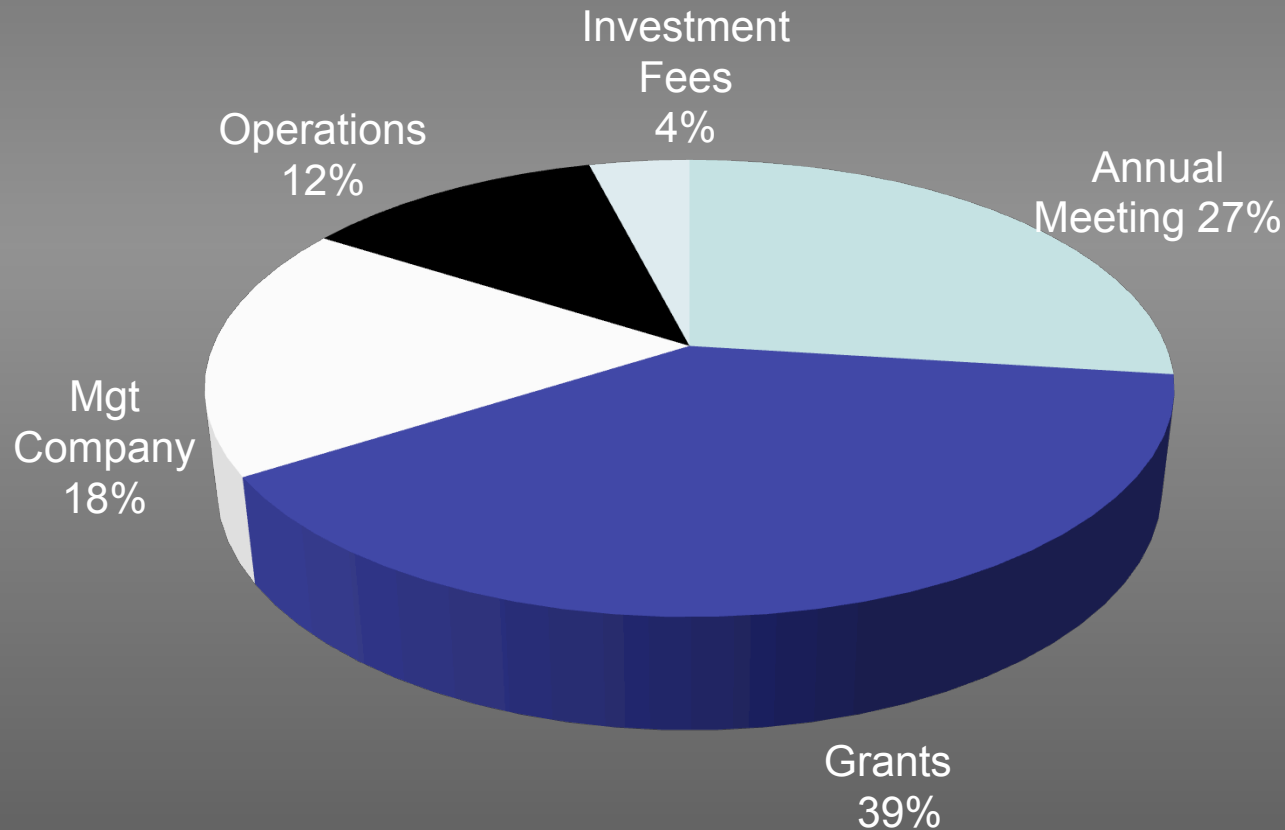

Balance Sheet

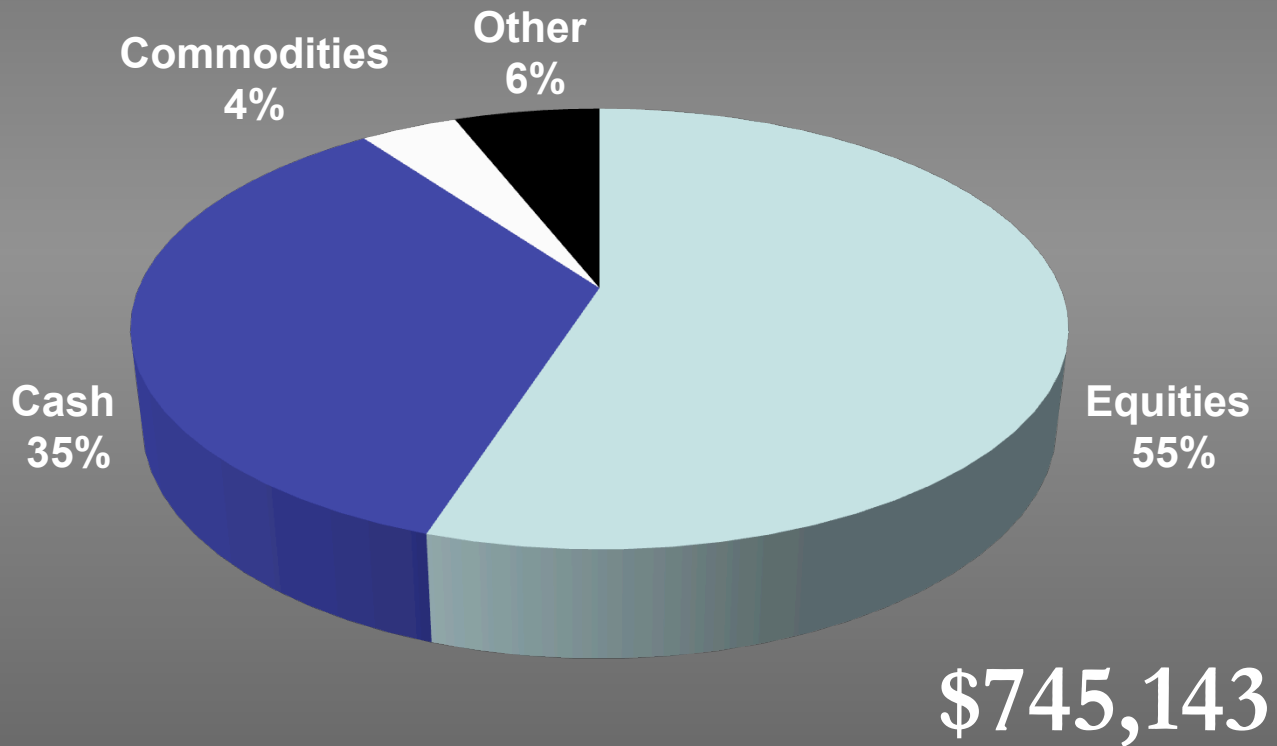

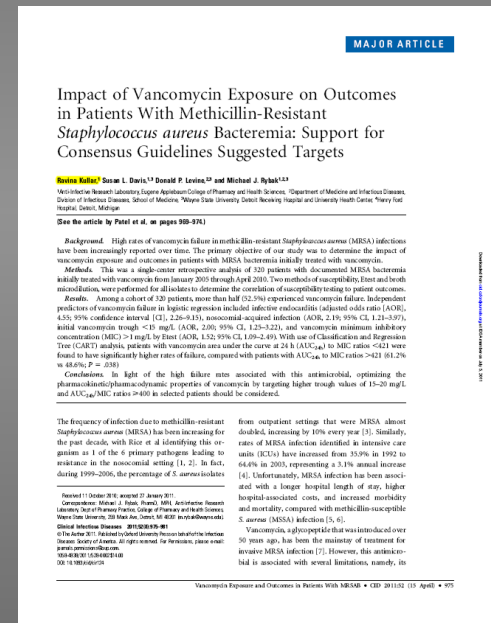
